Bridging Unit Tasks: BTEC Health and Social Care 2022

Try to complete one task from each section of the grid. With a minimum of three in total.

Tasks

- Review a case study in a short article which could be from a news website that you have research where an individual (child or adult) has been the victim of abuse in a health or social care environment (i.e care home, hospital etc).
- Research local health and social care provider. Produce a directory of them listing contract details, websites etc and indexing them appropriately. Aim for at least 30 settings.
- Research the Equal Opportunities Act 2010 and describe how this may impact on Health & Social Care Settings: https://www.gov.uk/guidance/equality-act-2010-guidance
- Find at least 5 examples of job vacancies or apprenticeships within 10 miles of Hucknall in the caring professions. For each one record what qualifications are required
- Write a summary review of a documentary you have watched using BBC iplayer, YouTube or
 other sources where the health and safety procedures in an institution have been questioned,
 this could be any institution it does not have to be H&SC related.
- Read two article from professional journals such as the nursing times, skills for life care magazine, produce an extract to highlight the key points.
- Write an account of a government led piece of legislation which is relevant to Health and social
 care this could relate to health and safety, data protection or the quality of care received by
 patients i.e Health and Safety at Work Act 1974, Management of Health and Safety at Work
 Regulations 1999, Food Safety Act 1990, Food Safety (General Food Hygiene) Regulations 1995,
 Manual Handling Operations Regulations 1992. It should include the relevance and importance
 of the legislation.
- Over the summer keep a reflective journal of your interactions with a range of people, for each interaction you should record the date, who the interaction was with, what happened then review looking at positives, negatives and what you have learnt from it. You should aim for about 12 interactions in your journal.
